Costs for photos are included in the course fee, except for associated services such as hair and makeup or renting of garments.

DESIGN MODELS have the right to use photos of students for marketing purposes.

Students will not be allowed to participate in any fashion event of photoshoot, unless prior consent of DESIGN MODELS is acquired.

Models and students can also not contract themselves in at any other agency, unless prior written consent by DESIGN MODELS has been acquired. DESIGN MODELS will market their students for modeling assignments, or propose their models to bigger agencies, if the student do so wish. No guarantee however, is given that we will find assignments for the models

If any assignment is allocated to the student or model, DESIGN MODELS is entitled to 20% of the fee payable to the student/model. Promotional work is also included in this.

If any photo's of the student/model are being used for any business or marketing purposes, eg marketing pamphlets, newspaper advertising, etc, the name of DESIGN MODELS have to be mentioned on the particular marketing document.
